Overview

The Provincial Advisory Council for the Inclusion of Persons with Disabilities (Advisory Council) was established in 2009 by the Provincial Government of Newfoundland and Labrador to advance inclusion and accessibility.

The Advisory Council shares its expertise and knowledge and advises the Provincial Government on disability-related issues and on the identification, removal and prevention of barriers to inclusion.

Mandate

The Advisory Council's mandate is to advise and inform the Minister Responsible for the Status of Persons with Disabilities (Minister Responsible) on matters concerning persons with disabilities in Newfoundland and Labrador.

The Advisory Council:

- Brings knowledge and understanding of disability-related issues to the Provincial Government,
- Advises the Provincial Government as it develops policies, programs, strategies and recommendations to advance the inclusion of persons with disabilities, and
- Promotes awareness of barriers experienced by persons with disabilities.

Values

The Advisory Council supports the following values:

- Access – providing equitable access to the same opportunities, on an equal basis with others
- Respect – Understanding that everyone is different, valuing everyone's contribution and treating everyone with dignity
- Inclusion – promoting full and effective participation in all aspects of society
- Choice – having choice on an equal basis as others
- Self Determination – making informed choices that are free of persuasion and based on one's own personal beliefs, values, interests and goals; the right to have full control of one's own life
- Privacy – maintaining the confidentiality of personal information that is important and sensitive

Vision

Newfoundland and Labrador will be a province where persons with disabilities have the same opportunities and benefits as persons without disabilities – a society that is fully accessible and inclusive.

Physical Location

The Advisory Council does not have an office or physical location. The Advisory Council can be contacted through the Disability Policy Office, which is located within the Department of Seniors, Wellness and Social Development, 3rd Floor, Confederation Building, West Block, St. John's, Newfoundland and Labrador. The Disability Policy Office acts as secretariat to the Advisory Council.

Representation

The Advisory Council has 12 to 18 volunteer members who are appointed by the Minister Responsible for the Status of Persons with Disabilities (the Minister Responsible). The Minister Responsible appoints the Chair of the Advisory Council to serve a three-year term and the members are appointed for two-year terms. The Advisory Council meets four times a year, (see Appendix A: Terms of Reference and Appendix B: Advisory Council Membership).

Advisory Council representation consists of an urban-rural balance with regional representation, gender balance and representation of different types of disabilities. New and returning Advisory Council members were last appointed in February 2014. An interim member was appointed in July 2015 to bring expertise in Deaf culture.

The Advisory Council members' two year term expired in January 2016. Members accepted the Minister Responsible's request to stay on as interim members until the next nomination process.

Primary Clients

The Advisory Council brings knowledge and understanding of disability issues to the Provincial Government and advises Government on initiatives to advance the inclusion of individuals with disabilities in all aspects of society. In this capacity, the Advisory Council serves its primary client, the Government of Newfoundland and Labrador, by providing advice to the Minister Responsible and other levels of government.

Description of Expenditures

Advisory Council members are appointed from the public and do not receive remuneration. Advisory Council members are reimbursed for expenses and travel costs. The travel expenses and costs associated with the work of the Advisory Council are covered by the Department of Seniors, Wellness and Social Development (SWSD) and are included in its departmental budget.

In 2015-16, \$62,600 was spent to cover costs associated with work of the Advisory Council, primarily four face-to-face meetings. This included \$11,365 for travel expenses and \$51,236 meeting costs and individual supports such as sign language interpretation, captioning services, and audio support.

Shared Commitments

The Advisory Council shares the Government's commitment to advance inclusion in all aspects of society throughout the province. This means identifying barriers experienced by persons with disabilities, and developing strategies and initiatives to both remove and prevent new barriers. Inclusion influences all aspects of an individual's life such as family, community, recreation, education, employment, and access to information, access to services and access to opportunities.

This commitment is reflected in the Provincial Strategy for the Inclusion of Persons with Disabilities and its Action Plan. This commitment is also aligned with the United Nations Convention on the Rights of Persons with Disabilities (the Convention). The Convention promotes and protects all rights and freedoms of persons with disabilities, so that individuals have full participation, dignity and respect to live in society on an equal basis with others. The commitment to an inclusive society is expanding to all sectors including private businesses, community groups and other public organizations.

Through the course of its work, the Advisory Council engaged with various departments and agencies of Government, including Advanced Education and Skills, Health and Community Services, Communications Branch, Education and Early Childhood Development, Seniors, Wellness and Social Development, Office of the Chief Electoral Officer, Office of the Chief Information Officer and the Policy Innovation and Accountability Office, NL Human Rights Commission, and the chairperson of the Buildings Accessibility Advisory Board. Collaboration with officials for these various Government departments and agencies contributed to achievements during year.

Collaboration with external organizations such as Coalition of Persons with Disabilities – NL also contributed to the work of Advisory Council. Inclusion influences all aspects of an individual's life such as family, community, recreation, education, employment, and access to information, services and opportunities.

Highlights and Accomplishments

The year ending March 31, 2016 has been full and rich with dialogue, deliberations and advice, which was provided to the Minister Responsible and Government departments on issues of importance for persons with disabilities in various areas. A few highlights of the past year include:

- Assistive Technology
 - Reviewed current systems of accessing AT including gaps and challenges; trends and best practices
 - Discussion with and advice to Minister Responsible on the need for expanding and realigning to Assistive Technology to be individualized, portable and responsive across one's lifespan
 - Advice paper developed and submitted on access to Assistive Technology and Devices
- Accessibility within electoral processes
 - Advice provided to the Minister Responsible on the need for greater accessibility within voting processes for provincial elections. This initiated work on issues of accessible elections such as poll stations accessibility, alternate formats availability and inclusive training of electoral staff and volunteers
 - Council engaged in meetings with Office of the Chief Electoral Officer staff (OCEO) and representative from Coalition of Persons with Disabilities on ways to ensure accessibility within electoral processes so that all voters can exercise their right to vote.
 - Partnership formed between Elections NL, Coalition of Persons with Disabilities–NL and the Disability Policy Office to produce ASL versions of electoral information and training and resources for all electoral staff
- Accessibility in built environment
 - Accessibility issues for heritage buildings were identified and specific advice provided to the restoration of the Colonial Building (St. John's), including dignified access to all floors and main entrance, provision of alternate formats, use of audio for storyboards and staff training in inclusive service delivery. The advice was welcomed by the department and will be used in future restoration projects.

The Advisory Council received presentations and engaged in discussions with Government officials, businesses, community organizations and experts who have disability experiences. This included:

- Representatives from the Newfoundland and Labrador Steering Committee on Securing Citizenship and Legal Capacity for All on new supported decision-making legislation and framework
- Office of the Chief Information Officer on web accessibility for Government

- Centre for Learning and Development on media and communications in Government
- Coalition of Persons with Disabilities-NL, Office of the Chief Electoral Officer and Elections Canada on accessible voting
- Deputy Minister of Seniors, Wellness and Social Development, Rocket Bakery Owner and Sobey's Estates manager on employment challenges and success in hiring persons with disabilities
- Consumers Health Awareness Network Newfoundland and Labrador (CHANNAL) on mental health awareness and stigma
- Office of Public Engagement on effective engagement of the public on policy issues
- Office of the Chief Electoral Officer on accessibility updates for provincial elections
- Disability Policy Office on current trends, jurisdictional scans, best practices

Report on Performance

The 2014-17 Activity Plan for the Advisory Council includes two key activities with objectives and measures:

- Advise the Provincial Government on the Provincial Strategy for the Inclusion of Persons with Disabilities.
- Advise the Provincial Government on issues of importance to persons with disabilities.

These activities with their objectives and measures will be monitored and used to evaluate the success of the activity plan. Through these activities, the Advisory Council will directly support goals of the Department of Seniors, Wellness and Social Development's (SWSD) to remove barriers and support inclusion for all.

The Advisory Council creates a yearly work plan with identified priority areas pertinent to the Provincial Strategy for Inclusion and matters of importance to persons with disabilities.

Priority areas in the 2015-16 work plan included:

- development of an universal definition of accessibility to support application of a disability lens on Government policy and decision making;
- accessible electoral processes with disability-related supports as required;
- access to assistive technology;
- equitable access to employment opportunities, including access to relevant supports and Government / community programs;
- engagement with community and Government to promote accessibility and inclusion;
- improved access to and delivery of disability-related supports that are individualized, flexible and responsive;
- enhanced effectiveness of building accessibility legislation;
- engagement with Government representatives and external stakeholders to promote action in universal design and web accessibility.

The work plan is a fluid document that the Advisory Council updates throughout the year.

The Advisory Council draws on the expertise and experiences of its membership, as well as that of external organizations, and research into current standards and best practices to advise Government on the implementation of the Strategy and matters of importance.

Activity 1: Provincial Strategy for the Inclusion of Persons with Disabilities

The Advisory Council's terms of reference include advising the Provincial Government on implementation of the Provincial Strategy for the Inclusion of Persons with Disabilities (Inclusion Strategy) and advising on matters of importance to persons with disabilities. These are reflected in the Advisory Council's Activity Plan 2014-2017.

Each year, the Advisory Council reports on objectives, measures and indicators as identified in their Activity Plan 2014-2017.

Objective

By March 31, 2016, the Advisory Council will have advised the Provincial Government on the Provincial Strategy for the Inclusion of Persons with Disabilities.

As of March 31, 2016, the Advisory Council had identified priority actions and tools to address issues and had provided advice on the Provincial Strategy for the Inclusion of Persons with Disabilities and its Action Plan. The Advisory Council will report on the same objective, measure and indicators in 2016-17.

Activity 2: Issues of importance to persons with disabilities

Over the past year, the Advisory Council engaged in and communicated about various disability-related issues with the Minister Responsible for the Status of Persons with Disabilities and other government officials. These included:

- Interdepartmental Working Group for the Inclusion of Persons with Disabilities representatives from the departments of Advanced Education and Skills, Education and Early Childhood Development, and Health and Community Services on the delivery of disability-related supports;
- Deputy Minister of Seniors, Wellness and Social Development on equitable access to employment;
- Assistant Deputy Minister of Advanced Education and Skills and departmental representatives on establishing a Provincial Supported Employment Committee;
- Department of Business, Tourism, Culture and Rural Development on accessibility of heritage buildings;
- Office of the Chief Electoral Officer on accessibility of elections;
- Minister Responsible and Minister of Justice and Public Safety on supported decision-making when considering physician-assisted dying.

Objective

By March 31, 2016, the Advisory Council will have advised on issues of importance to persons with disabilities.

During 2015-2016, the Advisory Council emphasized important issues related to persons with disabilities and advised the Minister Responsible and Government officials on solutions to address these issues such as accessibility in elections, access to services, employment, accessibility, and education.

The Advisory Council will report on the same objective, measure and indicators in 2016-17.

Opportunities & Challenges Ahead

The Advisory Council plays an important role in providing information and advice from a citizen perspective as Government develops public policy and manages public programs for the inclusion of persons with disabilities. While recognizing its role as advisory, the Advisory Council will continue to provide challenging research and intelligence that gives focus to the complex and evolving issues of inclusion, and to champion the changes required for a fully inclusive Newfoundland and Labrador.

Opportunities:

- The Advisory Council will continue to communicate and engage with the Minister Responsible for the Status of Persons with Disabilities, as well as other Provincial Government departments and agencies.
- The Advisory Council will continue its work according to the Activity Plan 2014-2017.
- The Advisory Council will continue to support and further the Provincial Government's commitment to inclusion for everyone in the province.

Challenge:

- The Advisory Council will provide relevant and current feedback to the Minister Responsible on the province-wide impact for persons with disabilities to access services and supports in the current economy (Budget 2016)

The Advisory Council will continue its journey towards an inclusive province for all Newfoundlanders and Labradorians.

Persons with disabilities want equal access; not special access.

Appendix A: Terms of Reference

Mandate

The Provincial Advisory Council for the Inclusion of Persons with Disabilities advises and informs the Minister Responsible for the Status of Persons with Disabilities on matters concerning persons with disabilities in Newfoundland and Labrador.

Role and Functions

The Advisory Council:

- Brings knowledge and understanding of disability-related issues to Government
- Advises Government as it develops policies, programs, strategies and makes recommendations to advance the inclusion of persons with disabilities
- Promotes awareness of the barriers faced by persons with disabilities

Membership and Structure

The Advisory Council is comprised of 12 to 18 members appointed by the Minister Responsible for the Status of Persons with Disabilities. From amongst the members, the Minister appoints the chair of the Advisory Council to serve a three year term. Advisory Council members are appointed for two years.

Advisory Council members serve in a volunteer capacity and do not receive remuneration other than reimbursement for expenses to attend meetings.

The Disability Policy Office provides secretariat and administrative support to the Advisory Council.

Nomination Process

Individuals with a broad knowledge and understanding of disability-related barriers and issues experienced by people with disabilities in this province and interested in serving on the Advisory Council shall either complete an Expression of Interest form or be nominated by a third party. Consideration is given to regional, cross-disability and urban-rural representation and gender balance. Nominations are accepted in alternate formats.

The Minister Responsible for the Status of Persons with Disabilities in Newfoundland and Labrador seeks nominations from:

- Members of the House of Assembly
- Community organizations working on disability-related issues
- The public

Advertisements are placed in newspapers province-wide, encouraging nominations to the Advisory Council based on the above noted criteria. Further information about the Advisory Council and nomination criteria is available from the Disability Policy Office via website, phone or email.

All public documents related to the Advisory Council are available in alternate formats upon request.

Accountability

The Advisory Council reports to the Minister Responsible for the Status of Persons with Disabilities. Under the **Transparency and Accountability Act**, the Advisory Council is a Category 3 Public Body and therefore must submit an annual report to be tabled in the House of Assembly. In addition, it must prepare and submit a three year activity plan.

Norman Austin

Norman Austin works with athletes with disabilities at national and provincial levels. He is a board member of Calypso Foundation, a coach for Special Olympics and a past member of Municipal Affairs Appeals Board. He is the father of a 34-year old son with an intellectual disability.



Elizabeth Chaulk

Elizabeth Chaulk is Associate Vice-President of Learner Services, College of the North Atlantic. She is an ex-officio member of the Provincial College of North Atlantic Advisory Committee for Learners with Disabilities. Delia Connell

Delia Connell is the Vice-President of Community Services/Aboriginal Affairs and Chief Operating Officer for Central/Northern Labrador with Labrador Grenfell Health. She is an active member and volunteer with local, regional, and provincial groups including Newfoundland and Labrador Association for Community Living, Happy Valley-Goose Bay Special Olympics, Happy Valley-Goose Bay Homelessness/Supportive Living and Happy Valley-Goose Bay Interdisciplinary Committee for Persons with Disabilities. Delia has a daughter who was born with Down Syndrome.



Don Connolly

Don is actively promoting awareness and inclusion for individuals with disabilities locally and nationally. He is President of the Canadian Advisory Council of the Blind-Newfoundland and Labrador Region. He is also a member of the St. John's Lions Club; and District Chair for Lions Clubs in District 4 which covers 52 Lions Clubs from Gander to St. John's. He is also President of VISRA-NL (Visually Impaired Sport and Recreation Association), and Coordinator of VISUAL (Visually Impaired Students and Seniors Committee Undertaking Active Living).

Lorna Gilbert

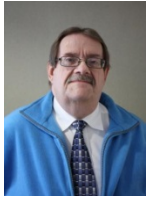

Dennis Gill

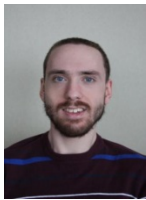
