TO ALL TO WHOM THESE PRESENTS SHALL COME,

GREETING;

A PROCLAMATION

WHEREAS by our Proclamation dated the 29th day of January, 1996, we did dissolve the Forty Second General Assembly of Our Province of Newfoundland;

AND WHEREAS it is Our Will and Pleasure to summon and call a General Assembly within Our said Province and for that purpose to direct the issue of Writs of Election for a General Election of Members to serve in the House of Assembly of Our said Province;

AND WHEREAS under the authority of section 35 of the *Election Act* (the "Act"), We are empowered to direct the issuance of a Writ of Election for the election of Members to the House of Assembly;

NOW KNOW YE that We do by this Our Proclamation direct that a Writ of Election for each of the electoral Districts hereinafter mentioned be issued;

AND WE DO further direct

1. That the date set to be the last day for the nomination of candidates for the Election in each Electoral District is Monday, the 12th day of February, 1996;

2. That the place in each Electoral District for the nomination of candidates for the said Election be as follows:

For the District of Baie Verte at the Town Council Office in Baie Verte.

For the District of Bay of Islands at the Main Lobby, Sir Richard Squires Building, Corner Brook.

For the District of Bellevue at the Town Hall in Chapel Arm.

For the District of Bonavista North at the Town Hall in Musgrave Harbour.

For the District of Bonavista South at the Provincial Court in Bonavista.

For the District of Burgeo & La Poile at the Town Hall in Port aux Basques.

For the District of Burin - Placentia West at the Town Hall in Marystown.

For the District of Cape St. Francis at the Provincial Court, Atlantic Place, St. John's.

For the District of Carbonear - Harbour Grace at the Town Hall in Carbonear.

For the District of Cartwright - L'Anse au Clair at the Community Hall in L'Anse au Loup.

3. That the day of polling in each Electoral District is Thursday, the 22nd day of February, 1996;
4. That a Writ of Election for the said Election be issued for each Electoral District in the Province; and
5. That the Writ of Election for each Electoral District shall be issued on Monday, the 29th day of January, 1996, and be returnable at the time and in the manner prescribed by section 82 of the *Act*, together with the return of the person to whom the writ is directed endorsed thereon, and all other documents and other things required to be transmitted to the Chief Electoral Officer by virtue thereof.
