TO ALL TO WHOM THESE PRESENTS SHALL COME,

GREETING;

A PROCLAMATION

WHEREAS by Our Proclamation dated the 29th day of January, 1996, We did direct that a Writ of Election be issued for each of the Electoral Districts therein named;

AND WHEREAS under the authority of section 56 of the *Election Act* (the *Act*) the Lieutenant-Governor in Council of Our Province of Newfoundland may, in addition to the polling stations established under section 55 of the *Act*, by Proclamation, establish one or more special polling stations for any Electoral District in any place in Our Province of Newfoundland outside of that Electoral District;

AND WHEREAS We deem it desirable to establish special polling stations for the Electoral Districts hereinafter referred to outside these Electoral Districts;

NOW KNOW YE that We do by this Our Proclamation establish the following Special Polling Stations for the following Electoral Districts at the places hereinafter named for the respective Electoral Districts outside of that Electoral District in respect of the General Election to be held in all Electoral Districts on Thursday the 22nd day of February, 1996.

The following Special Polling Stations are for the use of the General Public:

1. BAIE VERTE:

A Special Polling Station in the Central Newfoundland Regional College of Applied Arts, Technology and Continuing Education, BAIE VERTE CAMPUS, BAIE VERTE in the Electoral District of Baie Verte for all Electoral Districts with the exception of the Electoral District of Baie Verte.

2. BONAVIDA SOUTH:

A Special Polling Station in the Eastern College of Applied Arts, Technology and Continuing Education, BONAVIDA CAMPUS, BONAVIDA, in the Electoral District of Bonavista South for all Electoral Districts with the exception of the Electoral District of Bonavista South.

3. BURGEO AND LA POILE:

A Special Polling Station in the Westviking College of Applied Arts, Technology and Continuing Education, PORT AUX BASQUES CAMPUS, PORT AUX BASQUES, in the Electoral District of Burgeo & La Poile, for all Electoral Districts with the exception of the Electoral District of Burgeo & La Poile.

4. BURIN-PLACENTIA WEST:

A Special Polling Station in the Eastern College of Applied Arts, Technology and Continuing Education, BURIN CAMPUS, BURIN in the Electoral District of Burin-Placentia West for all Electoral Districts with the exception of the Electoral Districts of Burin-Placentia West and Grand Bank.

5. CARBONEAR-HARBOUR GRACE:

A Special Polling in Eastern College of Applied Arts, Technology and Continuing Education, CARBONEAR CAMPUS, CARBONEAR in the Electoral District of Carbonear-Harbour Grace, for all Electoral Districts with the exception of the Electoral Districts of Carbonear-Harbour Grace, and Port De Grave.

6. CONCEPTION BAY EAST AND BELL ISLAND:

A Special Polling Station in the Cabot College of Applied Arts, Technology and Continuing Education, BELL ISLAND CAMPUS, BELL ISLAND in the Electoral District of Conception Bay East & Bell Island, for all Electoral Districts with the exception of those Polling Divisions in the Bell Island part of the Electoral District of Conception Bay East & Bell Island.

7. GANDER:

A Special Polling Station in the Central Newfoundland Regional College of Applied Arts, Technology and Continuing Education, GANDER CAMPUS, GANDER in the Electoral District of Gander, for all Electoral Districts with the exception of the Electoral District of Gander.

8. GRAND FALLS-BUCHANS:

A Special Polling Station in the Central Newfoundland Regional College of Applied Arts, Technology and Continuing Education, GRAND FALLS CAMPUS, GRAND FALLS, WINDSOR in the Electoral District of Grand Falls-Buchans, for all Electoral Districts with the exception of the Electoral District of Grand Falls-Buchans.

9. HUMBER WEST:

A Special Polling Station in the Westviking College of Applied Arts, Technology and Continuing Education, CORNER BROOK CAMPUS, Fisher Building, Corner Brook in the Electoral District of Humber West, for all Electoral Districts with the exception of the Electoral District of Humber West.

10. LABRADOR WEST:

A Special Polling Station in the Labrador College of Applied Arts, Technology and Continuing Education, LABRADOR WEST CAMPUS, LABRADOR CITY in the Electoral District of Labrador West, for all Electoral Districts with the exception of the Electoral District of Labrador West.

11. LAKE MELVILLE:

A Special Polling Station in the Labrador College of Applied Arts, Technology and Continuing Education, HAPPY VALLEY-GOOSE BAY CAMPUS, HAPPY VALLEY-GOOSE BAY in the Electoral District of Lake Melville, for all Electoral Districts with the exception of the Electoral District of Lake Melville.

12. LEWISPORTE:

A Special Polling Station in the Central Newfoundland Regional College of Applied Arts, Technology and Continuing Education, LEWISPORTE CAMPUS, LEWISPORTE in the Electoral District of Lewisporte, for all Electoral Districts with the exception of the Electoral District of Lewisporte.

13. PLACENTIA & ST. MARY'S:

A Special Polling Station in the Eastern College of Applied Arts, Technology and Continuing Education, PLACENTIA CAMPUS, PLACENTIA in the Electoral District of Placentia & St. Mary's, for all Electoral Districts with the exception of the Electoral District of Placentia & St. Mary's.

14. ST. GEORGE'S-STEPHENVILLE EAST:

A Special Polling Station in the Westviking College of Applied Arts, Technology and Continuing Education, BAY ST. GEORGE CAMPUS, STEPHENVILLE in the Electoral District of St. George's-Stephenville East, for all Electoral District with the exception of the Electoral District of St. George's-Stephenville East.

15. ST. JOHN'S EAST:

A Special Polling Station in the Cabot College of Applied Arts, Technology and Continuing Education, PRINCE PHILIP DRIVE CAMPUS, PRINCE PHILIP DRIVE in the Electoral District of St. John's East, for all Electoral Districts with the exception of the Electoral Districts of Cape St. Francis, Conception Bay South, Kilbride, Mount Pearl, St. John's Centre, St. John's East, St. John's North, St. John's South, St. John's West, Signal Hill-Quidi Vidi, Topsail, Virginia Waters, Waterford Valley and the Polling Divisions in the St. John's part of the Electoral District of Conception Bay East and Bell Island.

16. ST. JOHN'S EAST:

A Special Polling Station in Memorial University of Newfoundland at the Thompson Student Centre, in the Electoral District of St. John's East, for all Electoral Districts with the exception of the Electoral Districts of Cape St. Francis, Conception Bay South, St. John's Centre, St. John's North, St. John's South, St. John's West, Signal Hill-Quidi Vidi, Topsail, Virginia Waters, Waterford Valley and the Polling Divisions in the St. John's part of the Electoral District of Conception Bay East and Bell Island.

17. THE STRAITS & WHITE BAY NORTH:

A Special Polling Station in the Westviking College of Applied Arts, Technology and Continuing Education, St. ANTHONY CAMPUS, ST. ANTHONY in the Electoral District of The Straits & White Bay North, for all Electoral Districts with the exception of the Electoral District of The Straits & White Bay North.

18. TRINITY NORTH:

A Special Polling Station in the Eastern College of Applied Arts, Technology and Continuing Education, CLARENVILLE CAMPUS, CLARENVILLE in the Electoral District of Trinity North, for all Electoral Districts with the exception of the Electoral District of Trinity North.

19. WINDSOR-SPRINGDALE:

A Special Polling Station in the Central Newfoundland Regional College of Applied Arts, Technology and Continuing Education, SPRINGDALE CAMPUS, SPRINGDALE in the Electoral District of Windsor-Springdale, for all Electoral Districts with the exception of the Electoral District of Windsor-Springdale.

The following Special Polling Stations are for the exclusive use of inmates in CORRECTIONAL INSTITUTIONS hereinafter set forth:

1. EXPLOITS:

A Special Polling Station in the BISHOPS FALLS CORRECTIONAL CENTRE, BISHOPS FALLS in the Electoral District of Exploits, for all Electoral Districts with the exception of the Electoral District of Exploits.

2. HARBOUR MAIN-WHITBOURNE:

A Special Polling Station in the NEWFOUNDLAND AND LABRADOR YOUTH CENTRE, WHITBOURNE in the Electoral District of Harbour Main-Whitbourne, for all Electoral Districts with the exception of the Electoral District of Harbour Main-Whitbourne.

3. HUMBER WEST:

A Special Polling Station in the CORNER BROOK LOCK-UP, CORNER BROOK, in the Electoral District of Humber West, for all Electoral Districts with the exception of the Electoral District of Humber West.

4. LAKE MELVILLE:

A Special Polling Station in the LABRADOR CORRECTIONAL CENTRE, HAPPY VALLEY-GOOSE BAY in the Electoral District of Lake Melville, for all Electoral Districts with the exception of the Electoral District of Lake Melville.

5. PLACENTIA & ST. MARY'S:

A Special Polling Station in the SALMONIER CORRECTIONAL INSTITUTION, SALMONIER LINE, in the Electoral District of Placentia & St. Mary's, for all Electoral Districts with the exception of the Electoral District of Placentia & St. Mary's.

6. ST. GEORGE'S-STEPHENVILLE EAST:

A Special Polling Station in the NEWFOUNDLAND AND LABRADOR CORRECTIONAL CENTRE FOR WOMEN, STEPHENVILLE, in the Electoral District of St. George's-Stephenville East, for all Electoral Districts with the exception of the Electoral District of St. George's-Stephenville East.

7. ST. GEORGE'S-STEPHENVILLE EAST:

A Special Polling Station in the WEST COAST CORRECTIONAL CENTRE, STEPHENVILLE in the Electoral District of St. George's-Stephenville East, for all Electoral Districts with the exception of the Electoral District of St. George's-Stephenville East.

8. SIGNAL HILL-QUIDI VIDI:

A Special Polling Station in HER MAJESTY'S PENITENTIARY, ST. JOHN'S in the Electoral District of Signal Hill-Quidi Vidi, for all Electoral Districts with the exception of the Electoral District of Signal Hill-Quidi Vidi.

The Special Polling Stations hereinafter set forth are for the exclusive use of patients receiving acute care in the herein described treatment centres:

1. BURGEO AND LA POILE:

A Special Polling Station in the CHARLES R. LEGROW HEALTH CARE CENTRE in the Electoral District of Burgeo and La Poile for the Electoral District of Port au Port with the exception of all other Electoral Districts including the District of Burgeo and La Poile.

2. BURIN-PLACENTIA WEST:

A Special Polling Station in the BURIN PENINSULA HEALTH CARE CENTRE, SALT POND in the Electoral District of Burin-Placentia West for the Electoral Districts of Bellevue, and Grand Bank, with the exception of all other Electoral Districts including the Electoral District of Burin-Placentia West.

3. CARBONEAR-HARBOUR GRACE:

A Special Polling Station in the CARBONEAR GENERAL HOSPITAL, CARBONEAR in the Electoral District of Carbonear-Harbour Grace, for the Electoral Districts of Bellevue, Harbour Main-Whitbourne, Port De Grave and Trinity-Bay De Verde, with the exception of all other Electoral Districts including the Electoral District of Carbonear-Harbour Grace.

4. GANDER:

A Special Polling Station in the JAMES PATON MEMORIAL HOSPITAL, GANDER in the Electoral District of Gander for the Electoral Districts of Baie Verte, Bonavista North, Bonavista South, Terra Nova, Fortune Bay-Cape La Hune, Grand Falls-Buchans, Exploits, Lewisporte, Twillingate & Fogo, Trinity North and Windsor-Springdale, with the exception of all other Electoral Districts including the Electoral District of Gander.

5. GRAND FALLS-BUCHANS:

A Special Polling Station in the CENTRAL NEWFOUNDLAND REGIONAL HEALTH CARE CENTRE, GRAND FALLS in the Electoral District of Grand Falls-Buchans, for the Electoral Districts of Baie Verte, Bonavista North, Bonavista South, Exploits, Fortune Bay-Cape La Hune, Gander, Lewisporte, Terra Nova, Twillingate & Fogo, with the exception of all other Electoral Districts including the Electoral District of Grand Falls.

6. HUMBER EAST:

A Special Polling Station in the WESTERN MEMORIAL REGIONAL HOSPITAL, CORNER BROOK in the Electoral District of Humber East for the Electoral Districts of Baie Verte, Bay of Islands, Burgeo & La Poile, Humber Valley, Humber West, Port Au Port, St. Barbe, St. George's-Stephenville East and The Straits & White Bay North, with the exception of all other Electoral Districts including the Electoral District of Humber East.

7. KILBRIDE:

A Special Polling Station in the WATERFORD HOSPITAL, WATERFORD BRIDGE ROAD, ST. JOHN'S, in the Electoral District of Kilbride for all Electoral Districts, with the exception of the Electoral District of Kilbride.

8. LAKE MELVILLE:

A Special Polling Station in the MELVILLE HOSPITAL, HAPPY VALLEY-GOOSE BAY in the Electoral District of Lake Melville for the Electoral Districts of Cartwright-L'Anse Au Clair, Labrador West, and Torngat Mountains, with the exception of all other Electoral Districts including the Electoral District of Lake Melville.

9. ST. GEORGE'S-STEPHENVILLE EAST:

A Special Polling Station in the SIR THOMAS RODDICK HOSPITAL, STEPHENVILLE, in the Electoral District of St. George's-Stephenville East for the Electoral Districts of Burgeo & La Poile and Port Au Port, with the exception of all other Electoral Districts including the Electoral District of St. George's-Stephenville East.

10. ST. JOHN'S CENTRE:

A Special Polling Station in ST. CLARE'S MERCY HOSPITAL, ST. CLARE AVENUE, ST. JOHN'S in the Electoral District of St. John's Centre, for all Electoral Districts with the exception of the Electoral District of St. John's Centre.

11. ST. JOHN'S NORTH:

A Special Polling Station in the HEALTH SCIENCES CENTRE (THE GENERAL HOSPITAL), PRINCE PHILIP DRIVE, ST. JOHN'S in the Electoral District of St. John's North for all Electoral Districts with the exception of the Electoral District of St. John's North.

12. ST. JOHN'S SOUTH:

A Special Polling Station in the GRACE GENERAL HOSPITAL, LEMARCHANT ROAD, ST. JOHN'S in the Electoral District of St. John's South for all Electoral Districts with the exception of the Electoral District of St. John's South.

13. SIGNAL HILL-QUIDI VIDI:

A Special Polling Station in the VETERAN'S PAVILION (LEONARD A. MILLER CENTRE), FOREST ROAD, ST. JOHN'S in the Electoral District of Signal Hill-Quidi Vidi, for all Electoral Districts with the exception of the Electoral District of Signal Hill-Quidi Vidi.

14. THE STRAITS & WHITE BAY NORTH:

A Special Polling Station in the CHARLES S. CURTIS MEMORIAL HOSPITAL, ST. ANTHONY in the Electoral District of The Straits & White Bay North, for the Electoral Districts of Baie Verte, Cartwright-L'Anse Au Clair, Lake Melville, St. Barbe and Torngat Mountains, with the exception of all other Electoral Districts including the Electoral District of The Straits & White Bay North.

15. TRINITY NORTH:

A Special Polling Station in the DR. G.B. CROSS MEMORIAL HOSPITAL, CLARENVILLE in the Electoral District of Trinity North for the Electoral Districts of Bellevue, Bonavista South and Terra Nova, with the exception of all other Electoral Districts including the Electoral District of Trinity North.

Additional Regular Polling Stations shall be established in respect of Health Care Institutions and Correctional Institutions for those Electoral Districts in which the following facilities are located.

In addition to the Special Polls heretofore identified Special Polls shall be established as follows to take the votes of electors in Special Work Environments:

1. TORNGAT MOUNTAINS:

A Special Polling Station at ANAKTALAK BAY in the Electoral District of Torngat Mountains for all Electoral Districts.

2. BELLEVUE:

A Special Polling Station at the HIBERNIA SITE in the Electoral District of Bellevue for all Electoral Districts, with the exception of the Electoral District of Bellevue.

3. BURGEO & LA POILE:

A Special Polling Station in the facilities known as ROYAL OAK MINES in the Electoral District of Burgeo & La Poile for all Electoral Districts.

4. TORNGAT MOUNTAINS:

A Special Polling Station at VOISEY'S BAY in the Electoral District of Torngat Mountains for all Electoral Districts.
