GREETING;

A PROCLAMATION

WHEREAS under the authority of section 35 of the *Election Act*, R.S.N. 1990, c.E-3, as amended (the "Act"), and pursuant to section 54 of the *House of Assembly Act*, R.S.N. 1990, c. H-10 as amended, upon the occurrence of a vacancy by the resignation of the sitting member on the 29th day of April, 1997, We are directed to issue a Writ of Election for the election of Members to the House of Assembly;

AND WHEREAS it is Our will and pleasure that a Writ of Election be issued for the Election of One Member to serve in the House of Assembly of Our Province of Newfoundland for the Electoral District of St. John's West;

June 27, 1997

NOW KNOW YE, THAT WE, do by this Our Proclamation direct that a Writ of Election for the Electoral District of St. John's West be issued;

AND WE DO further direct

1. That the date set to be the last day for nomination of candidates for the Election is Friday, the 11th day of July, 1997;
2. That the place for the nomination of candidates is the Cowan Heights United Church, Frecker Drive, St. John's;
3. That the day of polling for the Election is Monday, the 21st day of July, 1997;
4. That the Writ of Election shall be issued on Friday, the 27th day of June, 1997 and be returnable at the time and in the manner prescribed by section 82 of the Act, together with the return of the person to whom the writ is directed endorsed thereon, and all other documents and other things required to be transmitted to the Chief Electoral Officer by virtue thereof.
