GREETING;

A PROCLAMATION

WHEREAS by Our Proclamation dated the 27th day of June, 1997, We did direct that a Writ of Election be issued for the Electoral District of St. John's West;

AND WHEREAS under the authority of section 56 of The *Election Act* (the Act) the Lieutenant-Governor in Council of Our Province of Newfoundland may, in addition to the polling stations established under section 55 of the Act, by Proclamation, establish one or more special polling stations;

NOW KNOW YE that We do by this Our Proclamation establish the following Special Polling Stations for the Electoral District of St. John's West at the places hereinafter named in respect of the Election to be held in the Electoral District of St. John's West, on Monday, the 21st day of July, 1997:

The following Special Polling Stations are for the use of the General Public:

1. BURIN-PLACENTIA WEST:

A Special Polling Station in the College of the North Atlantic, Burin Campus, Burin, in the Electoral District of Burin-Placentia West for the Electoral District of St. John's West.

2. GANDER:

A Special Polling Station in the College of the North Atlantic, Gander Campus, Gander, in the Electoral District of Gander for the Electoral District of St. John's West.

3. GRAND FALLS-BUCHANS:

A Special Polling Station in the College of the North Atlantic, Grand Falls-Windsor Campus, Grand Falls-Windsor, in the Electoral District of Grand Falls-Buchans for the Electoral District of St. John's West.

4. HUMBER WEST:

A Special Polling Station in the College of the North Atlantic, Corner Brook Campus, Fisher Building, Corner Brook, in the Electoral District of Humber West for the Electoral District of St. John's West.

5. LAKE MELVILLE:

A Special Polling Station in the College of the North Atlantic, Happy Valley-Goose Bay Campus, Happy Valley-Goose Bay, in the Electoral District of Lake Melville for the Electoral District of St. John's West.

6. ST. GEORGE'S-STEPHENVILLE EAST:

A Special Polling Station in the College of the North Atlantic, Bay St. George Campus, Stephenville, in the Electoral District of St. George's-Stephenville East for the Electoral District of St. John's West.

7. THE STRAITS & WHITE BAY NORTH:

A Special Polling Station in the College of the North Atlantic, St. Anthony Campus, St. Anthony, in the Electoral District of The Straits & White Bay North for the Electoral District of St. John's West.

8. TRINITY NORTH:

A Special Polling Station in the College of the North Atlantic, Clarenville Campus, Clarenville, in the Electoral District of Trinity North for the Electoral District of St. John's West.

The following Special Polling Stations are for the exclusive use of inmates in Correctional Institutions hereinafter set forth.

1. HARBOUR MAIN-WHITBOURNE:

A Special Polling Station in the Newfoundland and Labrador Youth Centre, Whitbourne, in the Electoral District of Harbour Main-Whitbourne for the Electoral District of St. John's West.

2. PLACENTIA & ST. MARY'S:

A Special Polling Station in the Salmonier Correctional Institution, Salmonier, in the Electoral District of Placentia & St. Mary's for the Electoral District of St. John's West.

3. ST. GEORGE'S-STEPHENVILLE EAST:

A Special Polling Station in the West Coast Correctional Centre, Stephenville, in the Electoral District of St. George's-Stephenville East for the Electoral District of St. John's West.

4. SIGNAL HILL-QUIDI VIDI:

A Special Polling Station in Her Majesty's Penitentiary, St. John's, in the Electoral District of Signal Hill-Quidi Vidi for the Electoral District of St. John's West.

5. TRINITY NORTH:

A Special Polling Station in the Newfoundland and Labrador Correctional Centre for Women, Clarenville, in the Electoral District of Trinity North for the Electoral District of St. John's West.

The Special Polling Stations hereinafter set forth are for the exclusive use of patients receiving acute care in the herein described treatment centres:

1. KILBRIDE:

A Special Polling Station in the Waterford Hospital, Waterford Bridge Road, St. John's, in the Electoral District of Kilbride for the Electoral District of St. John's West.

2. ST. JOHN'S NORTH:

A Special Polling Station in the Health Sciences Centre (The General Hospital), Prince Philip Drive, St. John's, in the Electoral District of St. John's North for the Electoral District of St. John's West.

3. ST. JOHN'S SOUTH:

A Special Polling Station in the Grace General Hospital, LeMarchant Road, St. John's, in the Electoral District of St. John's South for the Electoral District of St. John's West.

4. ST. JOHN'S CENTRE:

A Special Polling Station in the St. Clare's Hospital, LeMarchant Road, St. John's, in the Electoral District of St. John's Centre for the Electoral District of St. John's West.

5. SIGNAL HILL-QUIDI VIDI:

A Special Polling Station in the Veteran's Pavilion (Leonard A Miller Centre), Forest Road, St. John's, in the Electoral District of Signal Hill-Quidi Vidi for the Electoral District of St. John's West.
