#### A PROCLAMATION

WHEREAS in and by section 18 of An Act to Amend the Residential Tenancies Act, Chapter 5, SN 1997 (the "Act"), it is provided that the Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed it expedient that the Act shall now come into force on Saturday the 1st day of November, 1997.

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this our Proclamation declare and direct that the *Act to Amend the Residential Tenancies Act*, Chapter 5, Statutes of Newfoundland, 1997, shall come into force on Saturday, the 1st day of November, 1997.

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.
