GREETING;

A PROCLAMATION

WHEREAS by Our Proclamation dated the 18th day of January, 1999, We did dissolve the Forty Third General Assembly of Our Province of Newfoundland;

AND WHEREAS it is Our Will and Pleasure to summon and call a General Assembly within Our said Province and for that purpose to direct the issue of Writs of Election for a General Election of Members to serve in the House of Assembly of Our said Province;

AND WHEREAS under the authority of section 57 of the Elections Act, 1991 (the "Act"), We are empowered to direct the issuance of a Writ of Election for the election of Members to the House of Assembly;

NOW KNOW YE that We do by this Our Proclamation direct that a Writ of Election for each of the Electoral Districts hereinafter mentioned by issued:

AND WE DO further direct

(1) That the last day for the nomination of candidates for the Election is Saturday, the 30th., day of January, 1999 in all Electoral Districts;

That the Writ of Election for each Electoral District shall be issued on Monday, the 18th day of January, 1999, and be returnable at the time and in the manner prescribed by Division E of the act, together with the return of the person to whom the writ is directed endorsed thereon, and all other documents and other things required to be transmitted to the Chief Electoral Officer by virtue thereof.
