Short title

1. This Order may be cited as the Health Care Institutions Boards Continuation Order.

Definition

2. In this Order "minister" means the minister appointed under the Executive Council Act to administer the Hospitals Act.

Health Care Corporation of St. John's 3. A hospital board, known as the Health Care Corporation of St. John's, is continued to act in the place of the hospital authorities of those hospitals listed in Schedule A, and shall manage and control the operation of those hospitals, including all other facilities, services and programs operated or provided by or associated with them.

Avalon Health Care Institutions Board 4. A hospital board, known as the Avalon Health Care Institutions Board, is continued to act in the place of the hospital authorities of those hospitals listed in Schedule B, and shall manage and control the operation of those hospitals, including all other facilities, services and programs in operation or provided by or associated with them.

Central East Health Care Institutions Board 5. A hospital board, known as the Central East Health Care Institutions Board, is continued to act in the place of the hospital authorities of those hospitals listed in Schedule C, and shall manage and control the operation of those hospitals, including all other medical clinics, facilities and services operated or provided by or associated with them.

Central West Health Care Institutions Board 6. A hospital board, known as the Central West Health Care Institutions Board, is continued to act in the place of the hospital authorities of those hospitals listed in Schedule D, and shall manage and control the operation of those hospitals, including all other medical clinics, facilities and services operated or provided by or associated with them.

Labrador Health Services Board 7. The Labrador Health Services Board is continued to manage and control the operation of all health facilities, services and programs in Labrador except those in the communities from Norman Bay south, and shall manage and control the operation of those hospitals listed in Schedule E, including all medical clinics, nursing stations, community health centres, facilities, programs and services operated by or associated with the Grenfell Regional Health Services Board in the geographic area outlined.

Grenfell Regional Health Services Board 8. (1) The Grenfell Regional Health Services Board is continued to manage and control the operation of all health facilities, services and programs in communities on the Labrador Coast from Norman Bay south, on the west side of the Northern Peninsula from Bartlett's Harbour north, and on the east side of the Northern Peninsula from Harbour Deep north.

(2) The Grenfell Regional Health Services Board as continued in subsection (1) shall manage and control the operation of the hospitals listed in Schedule F, including all medical clinics, nursing stations, community health centres, facilities, programs and services currently operated by or associated with the Grenfell Regional Health Services board in the geographic area outlined in subsection (1).

Western Health Care Corporation 9. The Western Health Care Corporation is continued to act in the place of the hospital authorities of the hospitals listed in Schedule G and shall manage and control the operation of those hospitals, including all other medical clinics, facilities and services operated or provided by or associated with them.

Peninsulas Health Care Corporation 10. The Peninsulas Health Care Corporation is continued to act in the place of the hospital authorities of the hospitals listed in Schedule H and shall manage and control the operation of those hospitals, including all other medical clinics, facilities and services operated or provided by or associated with them.

Maximum membership 11. The boards continued in this Order shall consist of not more than 18 persons appointed by the minister.
