A PROCLAMATION

WHEREAS in and by Section 5 of The Mechanics' Lien (Amendment) Act, 1971, the Act No. 47 of 1971, it is provided that the said Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on Saturday, the First day of January, 1972;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that the said Act shall come into force on Satorday, the First day of January, 1972;

OF ALL WITICH OUR LOVING SUB-IECTS AND ALL OTHERS whom these presents may concern are hereby required to take notice and to govern themselves accordingly.
