(SPEECH FROM THE THRONE Delivered at the Closing of The Second Session of The Thirty-Sixth General Assembly of the Province of Newfoundland on Monday January 21st, 1974, by His Honour THE HONOURABLE E. JOHN A. HARNUM, Lieutenant-Governor).

MR. SPEAKER AND MEMBERS OF THE HONOURABLE HOUSE OF ASSEMBLY:

This Second Session of the Thirty-Sixth General Assembly of this Honourable House of Assembly is about to be prorogued but before releasing Honourable Members from their duties I wish to convey to them my thanks for the prudent and sympathetic attention given by them to the many and important matters brought before this Honourable House by my Ministers.
