

- (c) The levy imposed by sub-section 4(K)(a) and 4(K)(b) shall, where the eggs are sold or otherwise disposed of,
- (i) to a person who is not a grading station operator, be paid by the producer or,
 - (ii) to a grading station operator, be collected by the grading station operator to whom they are delivered, by the grading station operator deducting the amount of levy from the monies payable by him to the producer for the eggs.
- (d) The levies referred to in sub-sections (a) and (b) shall be paid by the producer, or grading station operator to the Newfoundland Egg Marketing Board at such address and at such times and in such a manner as the Board may direct."
5. This Order shall come into and remain into effect on the dates as specified in this order.

A PROCLAMATION

WHEREAS in and by section 40 of *The Environmental Assessment Act*, Chapter 3 of The Statutes of Newfoundland, 1980, it is provided that the said Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on Friday, the twenty-first day of November, 1980;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that the said Act shall come into force on Friday, the twenty-first day of November, 1980;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.
