#### REGULATIONS

- 1. These regulations may be cited as The Collections Regulations, 1985.
- 2. In these regulations "Act" means The Collections Acts.
- 3. (1) Application for registration as a collection agency under the Act shall be submitted in or as near to form "A" as set forth in the Schedule and shall be accompanied by the appropriate fee prescribed in section 4.
- (2) Application for registration as a collector under the Act shall be submitted in or as near to form "B" as set forth in the Schedule and shall be accompanied by the appropriate fee prescribed in section 4
- (3) The Registrar may require an applicant for renewal of a licence to complete the whole or specified portion of an application in form "A" or "B".
  - 4. The annual fee for registration shall be as follows:
