GREETING:

A PROCLAMATION

WHEREAS in and by Section 32 of *The Community Colleges Act*, Chapter 17 of the Statutes of Newfoundland, 1987, it is provided that this Act or any provision thereof shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on Monday, the 3rd day of August, 1987;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that *The Community Colleges Act* shall come into force on Monday, the 3rd day of August, 1987;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.

The Interchangeable Drug Products Formulary Regulations, 1987 (No. 2) under

The Generic Dispensing of Prescription Drugs Act

(Filed July 15, 1987)

Under and by virtue of the powers conferred by section 5 of The Generic Dispensing Prescription Drugs Act, I have made the following regulations.

REGULATIONS

- 1. These regulations shall be known as the Interchangeable Drug Products Formulary (Volume 14) Regulations, 1987.
- 2. The drugs and prices set forth in the Schedule attached hereto constitute the Interchangeable Drug Products Formular for the period of July 1, 1987 to December 31, 1987 exclusive.
- 3. Newfoundland Regulation 34/87 is repealed.
- 4. These regulations shall come into effect on the 1st day of July, 1987.
