GREETING:

A PROCLAMATION

WHEREAS in and by

- i) Section 63 of *The Support Orders Enforcement Act*, Chapter 58 of The Statutes of Newfoundland, 1988;
- ii) Section 23 of *The Reciprocal Enforcement of Support Orders Act*, Chapter 59 of The Statutes of Newfoundland, 1988;
- iii) Section 85 of *The Family Law Act*, Chapter 60 of The Statutes of Newfoundland, 1988, and
- iv) Section 90 of *The Children's Law Act*, Chapter 61 of The Statutes of Newfoundland, 1988,

it is provided that these Acts shall come into force on July 1, 1989 or on such earlier date to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Acts shall come into force on Monday, the 1st day of May 1989;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that:

- i) *The Support Orders Enforcement Act*;
- ii) *The Reciprocal Enforcement of Support Orders Act*;
- iii) *The Family Law Act*; and,
- iv) *The Children's Law Act*;

shall come into force on Monday, the 1st day of May, 1989.

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to governor themselves accordingly.

**ORDER**

1. This Order may be cited as the Joe Batt's Arm-Barr'd Island-Shoal Bay Municipal Planning Area Interim Development Order, 1989.

2. The Council of the Town of Joe Batt's Arm-Barr'd Island-Shoal Bay is hereby authorized to exercise control over all development that may take place within the Joe Batt's Arm-Barr'd Island-Shoal Bay Municipal Planning Area until such time as a scheme for the control and use of land has been prepared in accordance with section 37 of the Act and brought into effect in accordance with section 40 of the Act, or for a period of five years from the date of this Order, whichever is the sooner.
