- 2. Section 9 of the Regulations is amended by
 - (a) striking out the full stop in subsection (2) of section 9 and substituting the words and full stop "and the Registrar may permit such a vehicle to be registered for a minimum of one month for a fee of 1/12th of the annual fee set out in Column 2, subject to payment of a \$35.00 administrative fee for any amount less than the annual fee,"; and
 - (b) adding immediately after subsection (7) of section 9 the following:
 - "(8) If the registration date of a motor vehicle (other than a renewal of a vehicle registration) occurs after the 15th day of any month, the fee shall be calculated as if application were made on the 1st day of the following month, notwithstanding that registration may be effective on an earlier date."
- 3. (1) Subsection (2) of section 23 of the Regulations is amended by renumbering it as subsection (3) and by striking out the words and figures "subsection (1)" where they first occur and substituting the words and figures "subsections (1) and (2)."
 - (2) Section 23 is further amended by adding immediately after subsection (1) the following:
 - "(2) If a vehicle referred to in subsection (1) is registered for 4,500 kg or greater, the Minister may remit to a person referred to in subsection (1) a refund of the fee for the number of months remaining to the expiry date, excluding the current month, provided that the Registrar shall not issue any refund for any amount less than \$20.00."
- 4. Section 30 of the Regulations is amended by renumbering it as section 31 and by adding immediately after section 29 the following:
 - "30. Notwithstanding anything contained in these Regulations, the Registrar may round any fee downward to the nearest dollar if the fee assessed is a dollar amount plus an amount less than 50¢ and the Registrar may round any fee upward to the nearest dollar if the fee assessed is a dollar amount plus an amount of 50¢ or more."

Town of Arnold's Cove Municipal Planning Area under

The Urban and Rural Planning Act

Under and by virtue of the powers conferred by subsection (1) of section 12 of *The Urban and Rural Planning Act*, Chapter 387 of The Revised Statutes of Newfoundland, 1970, and all other powers enabling me in that behalf, I define the area herein described to be comprised in the Municipal Plan of the Town of Arnold's Cove to be known as the Town of Arnold's Cove Municipal Planning Area.

The Town of Arnold's Cove Municipal Planning Area, Newfoundland Regulation Number 926/78, is repealed.

TOWN OF ARNOLD'S COVE MUNICIPAL PLANNING AREA BOUNDARY
