TO ALL TO WHOM THESE PRESENTS SHALL COME,

GREETING:

A PROCLAMATION

WHEREAS in and by section 4 of An Act to Amend The Adoption of Children Act, 1972, Chapter 20 of the Statutes of Newfoundland, 1990, it is provided that the said Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on Monday the 1st day of October, 1990;

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that the said Act shall come into into force on Monday, the 1st day of October, 1990;

NEWFOUNDLAND REGULATION 227/90

Fogo Municipal Planning Area under The Urban and Rural Planning Act

(Filed September 26, 1990)

Under and by virtue of the powers conferred by subsection (1) of section 12 of *The Urban and Rural Planning Act*, and of all other powers enabling him in this behalf, I hereby define the area described in the attached schedule to be the Municipal Plan of the Town of Fogo and to be known as the Fogo Municipal Planning Area.

SCHEDULE

NOWN OF FOGO

MUNICIPAL PLANNING AREA BOUNDARY

Beginning at a point, on the highwater mark on the eastern bank of an unnamed river at the head of Hare Bay in Notre Dame Bay.

Thence in a southeasterly direction along the eastern bank of said river to the western shoreline of Milk Pond.

Thence in a general easterly direction along the southern shoreline of said pond to the southern bank of an unnamed river flowing into the eastern side of aforementioned pond.

Thence south 84°30' east a distance of 1450 m more or less to high point, on the eastern side of route 333.

Thence north 35°30' east a distance of 1800 m more or less to a high point.

Thence north 31°00' east a distance of 1800 m more or less, to a point on the eastern bank of an unnamed river flowing into Shoal Bay, said point being a distance of 400 m from Route 334.

Thence in a northwesterly direction along the eastern bank of said river to a point on the highwater mark of Shoal Bay.
