#### A PROCLAMATION

WHEREAS in and by Section 32 of An Act to Amend the Labour Standards Act, S.N. 1992 Ch. 17 ("the Act") it is provided that certain sections of the Act, to which section 32 refers, shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the aforementioned sections of the Act shall come into force on Thursday, the 15th of April, 1993;

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this our Proclamation declare and direct that sections 1, 17, subsections 19(3) and 20(3), sections 21, and 22, subsections 23(1), (2) and (3) and sections 24 to 28 of An Act to Amend the Labour Standards Act, Chapter 17 of the Statutes of Newfoundland, 1992, shall come into force on Thursday, the 15th day of April, 1993;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.
