#### A PROCLAMATION

NOW KNOW YE that We do by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that *An Act to Amend the Schools Act and the Education Act*, shall come into force on the date of publication of the Proclamation in *The Newfoundland Gazette*;
