GREETING:

A PROCLAMATION

WHEREAS in and by Section 26 of The Motorized Snow Vehicles and All-Terrain Vehicles Act, Chapter 243 of The Revised Statutes of Newfoundland, 1970, it is provided that the said

Act or any part thereof shall by proclamation of the Lieutenant-Governor in Council come into

- (a) in the entire province; or
- (b) in any area of the province specified in such a proclamation on a day to be fixed by such a proclamation, and different proclamations may be made with respect to different areas of the province;

AND WHEREAS it is deemed expedient that certain parts of the said Act shall come into force on Friday, the Twenty-third day of January, A.D., 1976;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that paragraphs (i) and (j) of subsection (1) of Section 24 and the whole of Section 25 of the said Act shall come into force in the entire province on Friday, the Twenty-third day of January, A.D., 1976;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.

on and from Tuesday, the 17th, day of February, 1976, to Saturday, the 28th, day of February, 1976, inclusive

and

LABRADOR CITY

on and from Monday, the 1st. day of March, 1976, to Wednesday, the 3rd. day of March, 1976, inclusive.

AND IF NECESSARY the presiding Judge of Our said Court shall have the power to extend the time thereof for two days or for such further period as may be necessary for the conclusion of any matter or cause then in course of trial or ready for trial.

AND of these presents, all Magistrates, Sheriff, Officers of the Constabulary and Royal Canadian Mounted Police, Bailiffs, Ke ers of Gaols and other officers in the execut of their offices about the premises and all a singular other persons whom these presents shall or may concern, are hereby required take due notice and govern themselves accoingly.
