1. The All Terrain Vehicles Regulations, 1987, are amended by adding immediately after section 8 the following:

"8.1 These regulations shall not apply in Labrador except for the following communities: Labrador City, Wabush, Churchill Falls, Goose Bay/Happy Valley, Northwest River, Sheshatshit, L'Anse-au-Clair, Forteau, Capstan island, Pinware, L'Anse-Amour, L'Anse-au-Loup, West St. Modeste, Red Bay and except for Provincial Highway Route No. 510 and Provincial Highway Route 520 between Happy Valley-Goose Bay and Northwest River and Provincial Highway Route No. 500 between the Quebec/Newfoundland border and Wabush."

- 1. Section 2 of The Retail Sales Tax Regulations, 1979 is amended by
 - (a) striking out the word "and" at the end of paragraph (i);
 - (b) striking out the period at the end of paragraph (j) and substitute a semicolon, followed by the word "and"; and
 - (c) adding immediately after paragraph (j) the following
 - "(k) Visiting Force" means a visiting force as defined under The Visiting Forces Act (Canada)."
