

Members Elect met in the Assembly Chamber on the afternoon of November 1, 2007 for the Swearing in Ceremony and Election of Speaker.

**SERGEANT-AT-ARMS:** All rise.

Mr. Clerk, His Honour the Lieutenant Governor has arrived.

**CLERK (MacKenzie):** Admit His Honour the Lieutenant Governor.

Please be seated.

As Clerk of the House of Assembly, it gives me great pleasure to welcome His Honour, all Members-Elect and invited guests.

This is the second time that the Queen's Representative in this Province, His Honour the Lieutenant Governor, will officiate at a Swearing In Ceremony for Members elected during a General Election, as he also officiated in 2003 for those elected to the 45<sup>th</sup> General Assembly. On behalf of my fellow House officers, the Clerk Assistant, the Law Clerk and the Sergeant-at-Arms, as well as all staff of the House of Assembly Service, I wish to state that we look forward to working with and serving all Members during the 46<sup>th</sup> General Assembly.

A Proclamation has been issued by His Honour the Lieutenant Governor under the Great Seal of the Province. It reads as follows:

To: William MacKenzie, Clerk of the House of Assembly and Elizabeth Murphy, Clerk Assistant of the House of Assembly – Greeting;

**WHEREAS** under section 128 of the *Constitution Act, 1867*, I, as Lieutenant Governor of the Province of Newfoundland and Labrador, am authorized to administer the Oaths or Affirmations of Allegiance to Her Majesty Queen Elizabeth II to those persons elected to be Members of the House

of Assembly in the General Election held on October 9, 2007;

**AND WHEREAS** the said section of the *Constitution Act, 1867*, further requires that the persons declared elected as Members during the General Election held on the said date must take their Oaths or Affirmations of Allegiance before they can take seats in the House of Assembly;

**NOW THEREFORE**, I, the Lieutenant Governor of the Province of Newfoundland and Labrador, do authorize and direct you, the said William MacKenzie and Elizabeth Murphy, or either of you, to request that the Members Elect gather in the House of Assembly Chamber on Thursday, November 1, 2007 at 2 o'clock in the afternoon in order to take their Oaths or Affirmations of Allegiance before me.

Your Honour, I am pleased to report that Mr. Paul Reynolds, the Chief Electoral Officer, has published a report in the October 26, 2007 edition of *The Newfoundland and Labrador Gazette* assuring us that forty-five Members Elect, were duly elected on October 9, 2007 and one Member Elect was acclaimed on October 5, 2007. All are entitled to take their oath or affirmation of allegiance and oath or affirmation of office. The October 26, 2007 edition of *The Newfoundland and Labrador Gazette* containing the Report of the Chief Electoral Officer is deemed to be tabled and formerly entered into the House records.

It should be noted that the Writ of Election has not been returned from the District of the Isles of Notre Dame. There is a recount presently taking place before the Supreme Court with respect to the election in that district. Also, the election in the District of Grand Falls-Windsor-Buchans will take place on November 6, 2007. Further, the Member Elect for Topsail is unavoidably absent today and will be sworn in at a later date.

During the ceremony to follow, each Member Elect will be called in the alphabetical order in which his or her district is inscribed on the Roll of Members - that is the large, hand printed document you see on the Table in front of the Clerk Assistant.

Members Elect will come forward, as they are called, to stand in front of His Honour, on the right side at the bottom of the Speaker's dais. A Volume of Holy Scripture, located on the small table, is held by the Member Elect if taking Oaths.

Each Member Elect will swear an oath of allegiance or affirm allegiance to Her Majesty Queen Elizabeth the Second, as Queen of Canada, before His Honour. This requirement is set forth in Section 128 of the *Constitution Act of 1867*.

Each Member Elect will also make an oath or affirmation of office. This requirement is set forth in Section 5 of the *House of Assembly Accountability, Integrity and Administration Act*. Samples of either the oaths or affirmations are printed and lying on each desk. We ask Members Elect to carry their copies as they come forward.

After completing the Oaths or Affirmations, each Member Elect will proceed to the Table near Ms Murphy, the Clerk Assistant, to sign the Members' Roll. Then, proceed to the end of the Table near Ms Proudfoot, the Law Clerk, to sign the Oath or Affirmation of Allegiance, and finally the Oath or Affirmation of Office. Once all Members have signed the Roll of Members, the signatures will be witnessed by His Honour, as well as the Clerk, Clerk Assistant and Law Clerk. A facsimile of the Members' Roll will be prepared by my Office and given to each Member as a memento of this event at a later date, as well as the original Oath or Affirmation of Allegiance, witnessed by His Honour.

We ask that you hold your applause during the ceremony.

**HIS HONOUR THE LIEUTENANT-GOVERNOR (Edward Roberts, ONL, QC):** Thank you, Mr. Clerk.

I think you have dealt with all of the formalities, but, just to be certain, I made a copy of Section 128 of the *Constitution Act, 1867*, which originally was known as the *British North America Act*. Here are the operative words. You paraphrased them; here are the actual words: "...every Member of a Legislative Council or Legislative Assembly of any Province shall before taking his..." - and I will add her, his or her - "...Seat therein take and subscribe before the Lieutenant Governor of the Province or some Person authorized by him or her, the Oath of Allegiance contained in the Fifth Schedule to this Act...".

On the advice of my Premier, I have not authorized anybody other than myself to administer the Oath in this instance, so I shall do so and I confirm that the Oath is, in fact, that set forth in the Fifth Schedule of the 1867 Constitution Act.

Please go ahead, Sir.

**HIS HONOUR THE LIEUTENANT GOVERNOR:** Before I complete my role in today's proceedings by witnessing the Roll of the Members, perhaps I could be permitted to say a few words. You do not have a Speaker, I am not sure there is anybody who could stop me at this stage.

Let me say to all collectively, as I think I said to each of you individually, to offer you my very warm congratulations on your election and to welcome back those who served in the previous Assembly, and a word of welcome to those who sit today in this House for the first time.

I cannot help but think back to the first time I took the oath - we only had one oath in those days. It was a much simpler world, I guess. It was in 1966. Forty-one years ago,

and almost forty-one years to the day, as I recollect the House met in November that year. The election was in September. I took the same oath seven more times. I believe the hon. gentleman from Baie Verte-Springdale is the only member here who has taken the oath eight times. He is still in the game - he may get to nine yet - I am not.

I have always considered being a Member of the House of Assembly a proud distinction, an honour conferred upon men and women by their citizens; perhaps the highest honour that our citizens here in Newfoundland and Labrador, fellow Newfoundlanders or fellow Labradorians can confer.

I wish you all joy of the job; all joy the next few years. I suspect you are in for an interesting period. The first House in which I sat there were thirty-nine sitting to the Speaker's left and three to the Speaker's right. In those days the desks were less fixed, I guess is the phrase. But, I wish you well and I know I speak for every person in this Province today when I say that our hopes ride with you all. God grant you all wisdom in your deliberations.

**CLERK:** Please be seated.

A Proclamation has been issued by His Honour the Lieutenant Governor, under the Great Seal of the Province, which reads as follows:

WHEREAS the Office of Speaker of the House of Assembly is vacant;

AND WHEREAS it is not expedient to call together the 46<sup>th</sup> General Assembly until the Members of the House of Assembly have proceeded to the choice of a Speaker;

NOW THEREFORE, I, the Lieutenant Governor of the Province of Newfoundland and Labrador, do authorize and direct you, the said William MacKenzie and Elizabeth Murphy, or either of you, to signify to the Members of the said House of Assembly on the 1<sup>st</sup> day of November, 2007 that it is my pleasure that they should proceed to choose some person to be their Speaker and to present such person for the Lieutenant Governor's approbation when I, or my successor, call the House of Assembly together in session.”

As of 4:30 yesterday afternoon, October 31, 2007, the deadline in accordance with the Standing Orders, only one candidate declared his or her intention to seek the Office of Speaker. Pursuant to the Standing Orders, I declare Mr. Roger Fitzgerald, the hon. Member for Bonavista South, elected as Speaker of the 46<sup>th</sup> General Assembly of Newfoundland and Labrador.

The hon. the Premier and the Opposition House Leader lead Mr. Fitzgerald to the Speaker's Chair.]

**MR. SPEAKER (Fitzgerald):** Mr. Premier, hon. Leader of Her Majesty's Loyal Opposition, and visitors to our House of Assembly.

First of all, I would like to congratulate all members who were successfully elected on October 9.

To offer oneself for politics, as the Lieutenant Governor referred, is certainly a humbling experience. When you see so many people rally behind your leader, your party, and believe in you, yourself, over a twenty-one day period, when you go out knocking on doors, delivering material, it is

a very, very humbling experience, but you never get involved by yourself. Your family is always involved, and I would like to recognize the families of all sitting members here today, especially my own family.

[Applause]

**MR. SPEAKER:** I would also like to recognize the member who occupied this Chair prior to me - for the first time in his life he is unemployed - the hon. Harvey Hodder. I thank you, Sir, on behalf of all sitting members, for the dignity and the impartiality that you brought to this office in your tenure.

[Applause]

**MR. SPEAKER:** I also take the opportunity today to thank the good people in Bonavista South who have supported me over the past six elections. In the first one I was not successful enough to be here, but the following five saw me sit here with great majorities thanks to the good people who came out and rallied behind me and rallied behind what we all believed in. As a result of that, while I came up short in 1989, I am very humbled to be returned in this election, five elections after.

I would like to thank all of the forty-six members who are sitting in this Assembly today for your words of support and encouragement as I made my telephone calls and campaigned for the election to the Speaker's Chair.

While there was no election, I have to refer to the Dean of the House of Assembly, the hon. Deputy Premier: How long has this acclamation been on the go?

[Laughter]

**MR. SPEAKER:** The political universe will change for me over the next four years, since I will not be engaging in debate in this Assembly. The Speaker of a democratic

Parliament must not only be impartial but must also be seen to be impartial.

Since I represent a rural district and I will have no voice at a caucus table, I will expect those members whom I will have access to, to take the voice and the concerns of the people I represent to the people who are decision makers.

As your Speaker, I pledge to be fair and reasonable in all matters affecting this office. I will treat all members with respect, and I will consult and take advice wisely.

I feel there is a need for the Speaker's office to become, especially at this time, actively involved in an outreach service, and I pledge and make a commitment today, as the Speaker in the Speaker's office, to accept any, or as many as we possibly can, invitations to go to the high schools of Newfoundland and Labrador, especially rural areas, to talk about the good things that happen within this Chamber and the commitment that hon. members bring when they are elected to come here and represent members' interests.

[Applause]

**MR. SPEAKER:** In fact, I have one invitation offered already and I intend to accept and carry out that function next week.

I fully intend to live up to the expectation of the people who elected me in a non-political way, and I feel in a non-political way I can still be a voice for the district that I represent and bring their concerns forward.

I do not intend to bore you with a long speech today. I have made many of those in the past fourteen and a half years, and I am certain I will hear many more, which I will not have a lot of control over, in the next four years.

In closing, I would like to refer to a statement taken from the Members' Handbook that was recently circulated. I

believe it might be attributed to the hon. John Fraser, a former Speaker with the House of Commons in Ottawa. It is simple and to the point. It reads: In any Legislature the minority has a right to be heard but the majority has a right to govern. I will repeat that: In any Legislature the minority has a right to be heard but the majority has a right to govern.

Ladies and gentlemen, this Speaker will be guided by these words.

On motion, Mr. Jack Byrne is elected Deputy Speaker of the House of Assembly.

**SOME HON. MEMBERS:** Hear, hear!

**MR. SPEAKER:** The hon. the Premier.

**MR. PREMIER:** Mr. Speaker, I would like to move that Mr. Tom Osborne, the Member for St. John's South, be elected Deputy Chair of Committees of the House of Assembly.

**MR. SPEAKER:** The hon. the Opposition House Leader.
