## SWEARING-IN OF MEMBERS

# **HANSARD**

Friday December 18, 2015

Members-Elect met in the Assembly Chamber on the morning of December 18, 2015, for the Swearing-In Ceremony.

### **SERGEANT-AT-ARMS:** All rise.

Madam Clerk, His Honour, the Lieutenant Governor, has arrived.

**CLERK (Ms. Barnes):** Admit His Honour the Lieutenant Governor.

**SERGEANT-AT-ARMS:** It is the wish of His Honour, the Lieutenant Governor, that all present be seated.

**CLERK:** Good morning.

As Clerk of the House of Assembly, it gives me great pleasure to welcome His Honour the Lieutenant Governor, the Hon. Frank Fagan, Her Honour, Mrs. Patricia Fagan, all Members-Elect and invited guests to this ceremony today.

Today, the Members-Elect gathered in this Chamber become Members of the House of Assembly for the Forty-Eighth General Assembly in our Province since 1833. On behalf of my fellow House Officers, as well as the staff of the House of Assembly Service, we look forward to working with and serving all members during the Forty-Eighth General Assembly.

Before we get started, I wanted to make a note that our Broadcast people have noted that we are having a slight problem with the web streaming. It is variable, it is intermittent, but I just wanted all members to be aware of that.

#### A PROCLAMATION

**WHEREAS** under section 128 of the *Constitution Act, 1867*, I, as Lieutenant Governor of the Province of Newfoundland and Labrador, am authorized to administer the Oaths

or Affirmations of Allegiance to Her Majesty Queen Elizabeth II to those persons elected to be Members of the House of Assembly in the General Election held on November 30, 2015;

AND WHEREAS under section 5 of the *House* of Assembly Accountability, Integrity and Administration Act, I, as Lieutenant Governor of the Province of Newfoundland and Labrador, am authorized to administer an Oath or Affirmation of Office to those persons elected to be Members of the House of Assembly in the said General Election:

AND WHEREAS the said sections of the Constitutions Act, 1867 and the House of Assembly Accountability, Integrity and Administration Act further require that the persons declared elected as Members during the General Election held on the said date must take their Oaths or Affirmations of Allegiance and Oaths or Affirmations of Office before they can take their seats in the House of Assembly.

NOW THEREFORE, I, the Lieutenant Governor of the Province of Newfoundland and Labrador, do authorize and direct you, the said Sandra Barnes and Elizabeth Murphy, or either of you, to request that the Members-Elect gather in the House of Assembly Chamber on Friday, December 18, 2015 at 10 o'clock in the morning in order to take their Oaths or Affirmations of Allegiance and Oaths or Affirmation of Office before me."

Your Honour, I am pleased to report that Mr. Victor Powers, Chief Electoral Officer, has published a report in the December 16, 2015 edition of *The Newfoundland and Labrador Gazette* assuring us that the forty Members-Elect were duly elected on November 30, 2015. All are entitled to take their Oath or Affirmation of Allegiance and Oath or Affirmation of Office. The December 16, 2015 edition of *The Newfoundland and Labrador Gazette* containing the Report of the Chief Electoral Officer is deemed to be tabled and formally entered into the House records.

It is noted that the Member-Elect for Topsail – Paradise is unavoidably absent today and will be sworn in at a later date.

During the ceremony, each Member-Elect will be called in the alphabetical order in which his or her district is inscribed on the Roll of Members; that is the large, hand-lettered document lying there on the Table of the House. The signed Roll of Members is then hung in the corridor outside of the Chamber.

Members-Elect will come forward, as they are called, to stand at the small lectern at His Honour's left. A Volume of Holy Scripture located on the small table is held by the Member-Elect if taking Oaths. Each Member-Elect will swear an Oath of Allegiance or affirm allegiance to Her Majesty Queen Elizabeth the Second, as Queen of Canada, before His Honour. This requirement is set forth in section 128 of the *Constitution Act*, 1867 for all Legislatures in Canada.

Each Member-Elect will also make an Oath or Affirmation of Office. This requirement is set forth in section 5 of the *House of Assembly Accountability, Integrity and Administration Act.* The individual Oaths or Affirmations for each Member-Elect have been left on your desks. You will find that there are two copies of each. We ask Members-Elect to take their copies with them when they come forward.

After completing the Oaths or Affirmations, each member will proceed to the Table to sign the Roll near Ms. Murphy, the Clerk Assistant. The member will then sign two copies of each Oath, one for House records and one for the member to retain.

Members are asked to leave the signed copies with Ms. Murphy at the Table as His Honour will sign them after the ceremony. Once all members have signed the Roll, His Honour, as well as the Clerk, Clerk Assistant and Law Clerk, will sign at the bottom. A facsimile of the Members' Roll will then be prepared by my office and given to each member as a memento of this event at a later date, along with the signed Oaths or Affirmations as witnessed by His Honour.

Because of time constraints, we ask that our guests hold applause until all Members-Elect have been sworn.

Your Honour, we will begin.
