A PROCLAMATION

WHEREAS in and by Section 34 of The Credit Reporting Agencies Act, 1973, the Act

No. 76 of 1973, it is provided that the said Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on the first day of April, 1974;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that the said Act shall come into force on the first day of April, 1974;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and the Great Seal of Newfoundland to be hereunto affixed.

WITNESS: Our trusty and well-beloved the Honourable E. John A. Harnum, Lieutenant-Governor in Our Province of Newfoundland.

CITY OF CORNER BROOK

WATER AND SEWERAGE AMENDMENT BY-LAW, 1974.

Made pursuant to the City of Corner Brook Act and the Water and Sewerage Corporation of Greater Corner Brook Act, 1951, as amended.

1. This By-Law may be referred to as the City of Corner Brook Water and Sewerage Amendment By-Law, 1974.

2. Sub-section (11) of Section 4 of the City of Corner Brook Water and Sewerage By-

Law 1988 as amended by the City of Corner Brook Water and Sewerage Amendment By-Law 1972 and the City of Corner Brook Water and Sewerage Amendment By-Law 1973 are repealed and the following substituted therefor:

"(11) Every owner of real property which has both water and sewerage services shall pay per annum a rate of one hundred dollars (\$100.00) for each household unit, commercial unit, industrial unit or unit of vacant land, together with the amount of six thousandths parts of the assessed value of the real property assessed from time to time by the City Assessor in terms of the Assessment Act".
