Proclamation declare and direct that the said
Act shall come into force on the tenth day
of January, 1975;

Presents may concern are hereby required to take notice and to govern themselves accordingly;

**URBAN AND RURAL PLANNING ACT
REVISED STATUTES OF
NEWFOUNDLAND, 1970**

MUNICIPAL PLANNING AREA

Under and by virtue of the powers conferred upon me by subsection (1) of Section 12 of The Urban and Rural Planning Act, Chapter 387 of The Revised Statutes of Newfoundland, 1970, and of all other powers enabling me in that behalf, I hereby define the area herein described to be comprised in the Municipal Plan of Lewisporte and to be known as the Lewisporte Municipal Planning Area.

The boundaries of the Lewisporte Planning Area are as follows:

Commencing at a point, said point being on the shore at Wigwam Point at the Northern Entrance to Burnt Bay; THENCE due East a distance of one decimal two zero (1.20) miles; THENCE due South a distance of one decimal zero (1.0) miles; THENCE South 26° West a distance of four decimal eight (4.8) miles; THENCE due West a distance of two decimal two (2.2) miles to a point on the eastern shoreline of an unnamed pond; THENCE following the sinuosities of the shoreline in a generally south-westerly direction to a point at the most southwesterly tip of this pond at which point a stream flows into the pond; THENCE West 37° North a distance of one decimal two (1.2) miles; THENCE North 19° East a distance of four decimal three (4.3) miles; THENCE North 68° 50' East a distance of four decimal two (4.2) miles to the point of commencement.

All Bearings being referred to the TRUE MERIDIAN.
