

"11. (1) Subject to subsection (2), the fee payable to a marriage licence issuer for a marriage licence is \$30.00.

(2) A marriage licence issuer may retain as his own fee, \$10.00 of the fee referred to in subsection (1) with the balance of \$20.00 for each licence issued being remitted by the marriage licence issuer to the Registrar General of Vital Statistics in accordance with section 27 of the Act."

2. These regulations come into force on the first day of November, 1979.
