

- (h) "Producer-vendor" means a producer who grades, packs or markets all or any portion of the regulated product produced by him.
3. This Order shall not apply to a producer in the Province of Newfoundland who owns less than 500 hens.

LEVIES

4. The Newfoundland Egg Marketing Board Order Number 172 is hereby amended by revoking paragraph 9(F) of Order Number 172 and by substituting therefore the following paragraph as paragraph 9(G):

"9(G) A service charge of two and a half (2.5) cents a dozen on all eggs marketed as provided for by the natural Products Marketing (Newfoundland) (Miscellaneous Provisions) Regulations, 1970, as amended, will be made by the Newfoundland Egg Marketing Board under the authority of the Newfoundland Egg Marketing Scheme, 1970, as amended, and such charges shall be imposed on each producer and paid to the Newfoundland Egg Marketing Board by the producer or his marketing agent under the terms and conditions as set forth under Sections 18(a), 18(b), 18(c), 18(d), 18(e), 18(f), and 18(g) under the sub-title of "Levies and Service Charges" as provided for under Order Number 194 of the Newfoundland Egg Marketing Board and dated at St. John's on the 7th day of March, 1983."

5. This Order shall come into effect on the 1st day of April, 1984 and shall remain into effect until changed by a new Order.

WHEREAS in and by section 11 of *The Judgement Interest Act*, Chapter 81 of The Statutes of Newfoundland, 1983, it is provided that the said Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on Wednesday, the 2nd day of April, 1984;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that the said Act shall come into force on Wednesday, the 2nd day of April, 1984;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Present may concern are hereby required to take notice and to govern themselves accordingly.

NEWFOUNDLAND REGULATION 64/84

The Judgment Interest Regulations  
under  
*The Judgment Interest Act*  
(O.C. 263/84)

(Filed March 26, 1984)

Under and by virtue of the powers conferred by section 8 of *The Judgment Interest Act*, the Act No. 81 of 1983, and of all other powers enabling him in this behalf, the Lieutenant-Governor in Council has been pleased to make the following regulations.

REGULATIONS

1. These Regulations may be cited as The Judgment Interest Regulations.
2. Interest shall be established by taking the rate as set by the Bank of Canada and subtracting 1%.
3. (1) The interest rate herein established shall not change until the Bank of Canada rate deviates by 1% point.  
(2) Notwithstanding subsection (1), the interest rate shall not change more frequently than once annually, on the first day of January in each year.
4. The Minister of Justice shall cause the interest rate to be published in *The Newfoundland Gazette* when it changes pursuant to section 3.
5. The Bank of Canada rate shall be that which is published by the Bank in its Weekly Financial Statistics publications.
