GREETING:

A PROCLAMATION

WHEREAS in and by section 18 of *The Occupational Therapists Act*, Chapter 12 of the Statutes of Newfoundland, 1987, it is provided that this Act shall come into force on a day to fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on Tuesday, the 27th day of October, 1987;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that *The Occupational Therapists Act* shall come into force on Tuesday, the 27th day of October, 1987;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.

St. John's Urban Region (Agriculture) Order, 1978 (Amdt.)
under
Development Areas (Lands) Act

ORDER

The Development Area of St. John's Urban Region (Agriculture) Order, 1978, for the Conception Bay South Area, is further amended to include with the area's boundary the land set forth in the attached Schedule.

**SCHEDULE A
MANUALS RIVER AREA**

ALL that piece and parcel of land beginning at a point on the western shoreline of Three Arm Pond and having co-ordinates of N 5,261,415 m and E 312,320 m;

Thence South forty-seven degrees West a distance of 330 metres to a point having co-ordinates of N 5,261,190 m and E 312,070 m;

Thence South eighty-seven degrees West a distance of 2,730 metres to a point having co-ordinates of N 5,261,075 m and E 309,340 m;

Thence due South a distance of 2,870 metres to a point having co-ordinates of N 5,258,220 m and E 309,340 m;

Thence South twenty-nine degrees East a distance of 420 metres to a point on the northern limit of the Trans Canada Highway having co-ordinates of N 5,257,850 m and E 309,540 m;

Thence following along the northerly limit of the Trans Canada Highway in a general easterly direction to the intersection of the Trans Canada Highway with Fowler's Road, said point having co-ordinates of N 5,257,930 m and E 311,100 m;
