TO ALL TO WHOM THESE PRESENTS SHALL COME,

GREETING:

A PROCLAMATION

WHEREAS Mount Pearl was duly incorporated as a Provincial Municipality on February 15, 1955, under The Local Government Act, Province of Newfoundland and Labrador.

AND WHEREAS in the ensuing years Mount Pearl has maintained and continued its status as a Provincial Municipality;

AND WHEREAS the Municipality of Mount Pearl has grown and developed physically, socially and economically, enjoying a strong financial position and providing a full range of quality municipal services to its citizens;

AND WHEREAS this established growth and prosperity continues, supported by fiscal stability, conscientious long-range planning and progressive policies;

AND WHEREAS MOUNT PEARL as a Municipality has supported and played an exemplary role in the development and betterment of Municipal Government in the Province;

AND WHEREAS Mount Pearl has submitted to the Minister of Municipal Affairs for the Province of Newfoundland and Labrador for status as a City with its own City Act;

AND WHEREAS the submission by Mount Pearl is meritorious and has met all requirements for City Status as determined by the Province;

AND WHEREAS an Act to incorporate The City of Mount Pearl has been debated and passed by the House of Assembly, and given Royal Assent on July 8, 1988;

AND WHEREAS in and by Section ⁴⁴³443 of The City of Mount Pearl Act, Chapter 35 of the Statutes of Newfoundland, 1988, it is provided that the said Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the said Act shall come into force on Thursday the twenty-first day of July, 1988;

NOW KNOW YE that We, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this Our Proclamation declare and direct that the said Act shall come into force on Thursday, the 21st day of July, 1988;

AT OUR GOVERNMENT HOUSE in Our City of St. John's, this 21st day of July, in the year of Our Lord one thousand nine hundred and eighty-eight and in the thirty-seventh year of Our Reign.
