A PROCLAMATION

WHEREAS in and by section 2 of *An Act to Amend the Waste Material Disposal Act No. 2*,
S.N. 1992, c.49 ("the Act") it is provided that the said Act shall come into force on a day to be
fixed by Proclamation of Our Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient the said Act shall come into force on Wednesday, the 1st of September, 1993;

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland, do by this our Proclamation declare and direct that *An Act to Amend the Waste Material Disposal Act No. 2*, Chapter 49 of the Statutes of Newfoundland, 1992, shall come into force on Wednesday, the 1st day of September, 1993;

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.
