The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for St. John's East (Mr. Murphy) made a Statement to congratulate Sara Sexton upon her induction into the Order of Newfoundland and Labrador.

The Member for St. John's South (Mr. Osborne) made a Statement to thank and commend those who were responsible for helping rescue and relocate the residents of Maplewood Apartments when fire broke out in the complex.

The Member for Burgeo – La Poile (Mr. Parsons) made a Statement to pay tribute to the late Dr. Richard Ernest Taor and to extend condolences to his family.

The Member for Lake Melville (Mr. Russell) made a Statement to pay tribute to the late Ms. Loretta Saunders.

The Member for Bellevue (Mr. Peach) made a Statement to congratulate Brandon Thorne who has been awarded the Ronald K. Kennedy scholarship.

The Member for Fortune Bay – Cape La Hune (Ms. Perry) made a Statement to congratulate Mrs. Sheila Mercer, who was chosen Citizen of the Year for the Town of Harbour Breton, and all award nominees.

The Honourable the Minister of Education (Mr. Jackman) made a Statement to recognize Kaetlyn Osmond for her outstanding performance at the Sochi Winter Olympic Games.

The Honourable the Minister of Tourism, Culture and Recreation (Mr. French) made a Statement to congratulate the participating athletes, the Town of Clarenville and the host committee on the success of the 2014 Newfoundland and Labrador Winter Games.

The Honourable the Minister of Justice (Mr. King) made a Statement to recognize the outstanding achievements of retired Royal Newfoundland Constabulary Chief of Police Robert P. Johnston and to welcome the recently-appointed Chief, William Janes.

NOW THEREFORE BE IT RESOLVED that Mr. Wayne L. Harnum be nominated for appointment as the Sergeant-at-Arms of the House of Assembly".

The Member for St. John's North (Mr. Kirby) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reinstate funding to the Coalition of Persons with Disabilities.

The Member for Signal Hill – Quidi Vidi (Ms. Michael) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to notify the C-NLOPB of its position on night flights, urging them to reject requests from offshore operators for a return to night flights on the Province's offshore, while encouraging them to develop a safer alternative for workers.

The Member for Burgeo – La Poile (Mr. Parsons) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to include the section of road between Channel-Port aux Basques and Stephenville in the 24-hour snow clearing project.

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reinstate the Family Violence Intervention Court.

The Member for Cartwright – L'Anse au Clair (Ms. Dempster) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to improve the Medical Transportation Programme so that all expenses are covered and reimbursed in a more timely manner.

The Chairperson of the Committee (Mr. Verge) reported that the Committee of Supply had considered the matters to them referred and had directed him to report that they had made some progress and ask leave to sit again.

On motion the report of the Committee of Supply was received and adopted and on motion it was ordered that the Committee have leave to sit again on tomorrow.

It was moved and seconded that when the House rose it would adjourn until tomorrow, Tuesday, March 18th at 1:30 o'clock in the afternoon.
