THEREFORE BE IT RESOLVED that all parties of this Honourable House call upon the Government of Canada to do its part to address the very serious issue of violence against Aboriginal girls and women by launching a national inquiry into missing and murdered Aboriginal women in Canada".

The Member for St. John's South (Mr. Osborne) gave notice that he would on tomorrow ask leave to introduce the following Resolution:

"WHEREAS Government has recently indicated that energy conservation was necessary to prevent rolling blackouts;

AND WHEREAS Nalcor has issued two energy conservation requests to the general public in 2014;

THEREFORE BE IT RESOLVED that this House urge Government to consider developing and introducing energy conservation programs for all ratepayers in our Province".

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reinstate the Family Violence Intervention Court.

The Member for Burgeo – La Poile (Mr. Parsons) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to finalize the design and begin construction of the new ferry vessels for residents of the South Coast of Newfoundland and Labrador.
