The Member for Bonavista South (Mr. Little) made a Statement to congratulate the Pee Wee Cabots Hockey Team which won the gold medal at the Subway Classic tournament.

The Member for Signal Hill – Quidi Vidi (Ms. Michael) made a Statement to congratulate Barb Doran and Noreen Golfman who have received Wave awards for their contributions to the Atlantic Canadian screen industry.

The Member for The Straits – White Bay North (Mr. Mitchelmore) made a Statement to recognize Tristan Earles for his compassion and generosity in raising funding for the family of Ashley Cull.

The Member for St. John's East (Mr. Murphy) made a Statement to congratulate Mrs. Nora Alteen who has celebrated her 102<sup>nd</sup> birthday.

The Member for Mount Pearl South (Mr. Lane) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to intervene in the matter and instruct the English School Board to develop more suitable options than those imposed by the Board to address overcrowding in St. Peter's Elementary and Mount Pearl Senior High.

The Member for Burgeo – La Poile (Mr. Parsons) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to negotiate a fair deal with ambulance operators that ensures the safety of ambulance professionals and patients.

The Member for Cartwright – L'Anse au Clair (Ms. Dempster) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to allocate resources to allow for permanent resurfacing of Route 510 from L'Anse au Clair to Red Bay.

The Member for St. Barbe (Mr. Bennett) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government in partnership with the private sector to extend cell phone coverage throughout Gros Morne National Park and the enclave communities within the Park.

Pursuant to notice and on motion debate commenced and concluded on the following Resolution standing in the name of the Member for Bonavista North (Mr. Cross), seconded by the Leader of the Opposition (Mr. Ball) and the Leader of the Third Party (Ms. Michael):

"WHEREAS the federal Department of Fisheries and Oceans, in allocating quotas for northern shrimp this year, has reduced the allocations for the inshore fleet disproportionately by adopting a "Last In, First Out" (LIFO) policy;

THEREFORE BE IT RESOLVED that this Honourable House calls on the Government of Canada to eliminate the "Last In, First Out" (LIFO) policy of the Department of Fisheries and Oceans and to instead distribute more equitably the northern shrimp quota allocations based on adjacency and historical dependence."

The Speaker put the question on the Resolution and declared the Resolution carried *nemine contradicente*.
