Pursuant to order and on motion the Bill entitled "An Act For Granting To Her Majesty Certain Sums Of Money For Defraying Certain Expenses Of The Public Service For The Financial Year Ending March 31, 2015 And For Other Purposes Relating To The Public Service" (Bill No. 11) was read the first, second and third time and passed.

On motion it was ordered that Bill No. 11 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for his Assent.

On motion of the Honourable the Government House Leader (Mr. King) the House resolved itself into a Committee of Ways and Means.

The Speaker left the Chair.

Mr. Verge took the Chair of Committee of the Whole House.

On motion the Committee rose.

The Speaker resumed the Chair.

The Chairperson of the Committee of the Whole House (Mr. Verge) reported that the Committee of the Whole House had considered the matters to them referred and had passed a certain Resolution and a Bill consequent thereto and recommended that Bill No. 12 be introduced to give effect to the Resolution.

On motion the report of the Committee was received and adopted.

Pursuant to order and on motion the following Resolution was read a first and second time:

"That it is expedient to bring in a measure respecting the imposition of taxes on tobacco." (Bill No. 12)

Pursuant to order and on motion the Bill entitled "An Act To Amend The Revenue Administration Act No. 2" (Bill No. 12) was read the first, second and third time and passed.

On motion it was ordered that Bill No. 12 be printed being entitled as above and that it be submitted to His Honour the Lieutenant Governor for his Assent.

By agreement the proceedings were suspended at 5:30 o'clock in the afternoon for the dinner break.

The Speaker resumed the Chair at 6:17 o'clock in the evening.

Pursuant to order and on motion debate commenced and concluded on Second Reading of a Bill entitled "An Act To Amend The Mineral Act" (Bill No. 15) and on motion it was ordered that Bill No. 15 be now read the second time.

Pursuant to order and on motion the Bill entitled "An Act To Amend The Mineral Act" (Bill No. 15) was read the second time and on motion it was ordered that Bill No. 15 be referred to a Committee of the Whole House now.

On motion of the Honourable the Government House Leader (Mr. King) the House resolved itself into a Committee of the Whole House.
