The House met at 1:30 o'clock in the afternoon pursuant to adjournment.

The Member for Conception Bay South (Mr. Hillier) took his seat.

The Member for St. John's East (Mr. Murphy) made a Statement to recognize Patricia Bryant for her dedication to her community as a volunteer.

The Member for Burgeo – La Poile (Mr. Parsons) made a Statement to congratulate Miss Julie Pink for placing second in the regional cross-country running competition.

The Member for Port de Grave (Mr. Littlejohn) made a Statement to congratulate Ms. Rebecca Shephard, recipient of the Constable W.C. Moss Scholarship; Joshua Thomas, Emily Mercer and Emily Peddle, recipients of Electoral District Scholarships and Matthew French who was awarded a Centenary of Responsible Government Scholarship.

The Member for Bellevue (Mr. Peach) made a Statement to congratulate April Drake who was named to the Canadian Ball Hockey Team which will represent Canada at the 2015 World Ball Hockey Championship in Switzerland in June, 2015.

The Member for Fortune Bay – Cape La Hune (Ms. Perry) made a Statement to congratulate Fire Chief Anthony Casey for being elected Director of Region Four on the Executive Board of the Newfoundland and Labrador Association of Fire Services.

The Member for Mount Pearl South (Mr. Lane) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to stop development by the Edinburgh Group of cottage lots at Ocean Pond, investigate the fact that they extensively developed this property without permission and hold a meeting with the Ocean Pond group to outline government's plans for the area and allow the existing residents to have input into decisions made in their cottage area.

The Member for St. John's North (Mr. Kirby) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to extend eligibility for the Intensive Applied Behavioural Analysis Program beyond Grade 3 in consultation with parents, advocates, educators, health care providers and experts in the autism community.

The Member for St. John's Centre (Ms. Rogers) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to reinstate the Family Violence Intervention Court.

The Member for Burgeo – La Poile (Mr. Parsons) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to include the section of road between Channel-Port aux Basques and Stephenville in the 24-hour snow clearing project.

The Member for Carbonear – Harbour Grace (Mr. Slade) presented a Petition from certain residents of the Province calling upon the House of Assembly to urge Government to have the Beach breakwater in the local service District of Freshwater – Carbonear repaired.
