The Member for Cartwright – L'Anse au Clair (Ms. Dempster) made a Statement to recognize Captain Lester Powell for his lengthy career in the airline industry.

The Member for Kilbride (Mr. Dinn) made a Statement to recognize the Lester family which was recognized for its contribution to NL Agriculture at the annual agriculture show.
