The Member for Labrador West (Mr. McGrath) made a Statement to congratulate the volunteers and participants who contributed to the success of the 40<sup>th</sup> Great Labrador Loppet.

The Member for Signal Hill – Quidi Vidi (Ms. Michael) made a Statement to congratulate Jessica Summers winner of two silver medals in snowshoeing at the Special Olympics Newfoundland and Labrador Provincial Winter Games.
